

GUIDELINES FOR PROVISIONAL ADMISSION TO Ph.D. IN THE SUBJECT MANAGEMENT STUDIES (ACADEMIC YEAR 2021-22)

Please note that VERY FEW seats are available at our Research Centre. The admission process will be very selective and is strictly in accordance with the UGC and affiliated University guidelines. All the prospective candidates qualifying the admission criteria are expected to follow the below mentioned procedure-

1. The provisional admission to Ph.D. (Arts) in Management Studies program for eligible candidates at Sasmira's Institute of Management Studies and Research, affiliated to University of Mumbai/ SNDT University, for the academic year 2021– 2022 is commencing from 05th May, 2021.
2. The last date to apply for the said programme is 05th June 2021 till 5.00 p.m.
3. The eligible candidates need to download Ph.D. (Arts) in Management Studies admission form from the institute's website at <http://www.simsr.sasmira.org/>
4. The duly filled form is to be submitted to the institute's office by the candidate during 10th May, 2021 to 05th June 2021 between 11.00 a.m. to 5.00 p.m. (except Sundays) along with the required documents. The documents required are-
 1. Self attested photocopy of Bachelor Degree Mark sheet and Certificate
 2. Self attested photocopy of Masters Degree Mark sheet and Certificate
 3. Self attested photocopy of the certificate showing eligibility / qualified for PET (Management Studies) conducted by University of Mumbai/ SNDT University
 4. Self attested photocopy of the certificate showing exemption from PET, if any. (Like M. Phil, NET / JRF qualification)
 5. Self attested photocopy of the Certificate showing work experience, if any.
 6. Attested photocopy of the Certificate of Name change, if any.
 7. 5 Sets of Research proposal in brief on the tentative research topic
 8. A Demand Draft for Rs.1,000/- (Rupees One Thousand Only) in favour of 'Sasmira's Institute of Management Studies and Research' payable at Mumbai

5. The eligible short listed applicants will be called for brief presentation on their tentative research topic and interview.
6. The exact schedule showing dates and time for presentation and interview will be informed individually (by email provided by them) to the candidates as well as put up on institute's website.
7. Subject to their selection, they will be provisionally admitted to the Ph.D. in Management Studies program and guide will be allotted.
8. Reservations will be applicable as per the government rules.
9. Selection would be based on Personal Interviews, Presentation of Research proposal and Approval of research proposal (applicants are supposed to bring their Research Proposal in PPT and hard copy form for interview).
10. Institution reserves the right to admit or reject the candidates at any or all stages of selection and admission. Dress Code for interview is strictly formals.
11. The conduct and completion of Ph.D program would be as per the rules and norms of the affiliated University, UGC guidelines and the Sasmira's Institute of Management Studies and Research as prescribed from time to time.
12. Dates and process of admission are subject to change without public notice in case of technical errors at the discretion of the management. All decisions made by the institute would be final and binding.
13. Applicant must have given latest qualifying examination from the University of Mumbai/ SNDT University
14. Applicants may be called for selection process after initial scrutiny of applications. Candidates would be given 10 days' notice before being called for the interview
15. Results and Fee details would be notified at an appropriate date and time on notice board and on the website of the Institute
